**(2) New Player Definition:** player was not registered in the Quesnel Ringette Association during 2008-2009 season.

**(3) Early Registration Deadline is June 30, 2009:** your completed registration form and cheques must be received on or before that date.

**(4) Registration Deadline for Returning Players is September 30<sup>th</sup>:** registrations received after this date will be assessed a \$25 admin fee.

**Registration Payment:** the first half of the registration fee will be required before September 30<sup>th</sup>, with the balance to be post dated no later than December 31<sup>st</sup>. Confidential alternate payment arrangements can be made with the Treasurer. **NSF CHARGE \$25.00**

Due to insurance reasons, players will not be allowed on the ice if first half of registration fee has not been received by Sept. 30, 2009.

**Family Discount:** save \$100 for families with three or more players registered – ask for more details.

**Goalie Discount:** Novice to Belle, each team will have \$100 to apply to dedicated goalie(s) – ask for more details.

**Children's Fitness Tax Credit:** total registration fee is applicable for children who qualify.

**KidSport Program:** financial assistance may be available – see website or ask Registrar for more details.
